Your navigation authority



- Independent navigation authority for Cambridge, formed by Act of Parliament in 1702
- Prime duty is to maintain navigation
- Statutory powers and byelaws
- Area of jurisdiction: Grantchester to Bottisham

Managing the River Cam

- Conservancy Area defined in three sections:
 - Upper River (Byron's Pool to the Anchor Pub)
 - Middle River (the Backs to Jesus Sluices)
 - Lower River (Jesus Sluices to Bottisham Lock)

Administration: Baits Bite Lock





Operations: Clayhithe

Rules of the navigation

- Signage based on byelaws
- For your safety
 - -E.g.
 - sign upstream of Baits Bite danger, sluices ahead
 - change priority signs, Plough Reach



In order to navigate safely on a crowded river, it is necessary to understand about other boats:




Ability to Manoeuvre



A few things about powered vessels


Restricted

- Some power boats go a lot more slowly than you do
- Diesel engines are noisy

Irritating/dangerous things rowers can do

• Overtaking, then stopping or spinning

Overtaking on the starboard side

• Squeezing past the bow or stern of a boat that is turning

General Points

- Look and think ahead
- Duty to avoid collisions
- Generally boats do not go in the direction they are pointing
- Be patient
- Sound signals

Sound signals


- One blast turning to starboard
- Two blasts turning to port
- • Three blasts operating astern propulsion

Five or more blasts - What are your intentions? (get out of my way)

General Behaviour

- Sound carries across water
- Please avoid bad language
- Report unacceptable behaviour
- Be considerate to fishermen poles difficult to see
- Be careful of wildlife

River Cam Corridor



The River is a County Wildlife Site









Moored Boats

- They are entitled to be there Licence Holders
- They are not an extension of the bank
- On narrow-boats, if necessary push off against fenders or the tarred bottom above the waterline
- Never push off against the hull of a wooden or plastic boat (CUCBC Handbook guidance, R)
- Please do not practice racing starts beside moored residential boats
- People live on boats unexpected movement can cause accidents
- Apologise and own up honesty is appreciated

Events in Conservancy Area

- Over 180 'approved' events on River in 2009
 - E.g. club racing at Cam Sailing Club, rowing regattas, Cam Canoe & Kayak Marathon, sponsored walks along the Towpath, charity duck races etc.
- River Manager requires 28 days' notice from organisers to approve
- Events published within Conservancy notice-boards and on website
- Banner for Baits Bite footbridge



• <u>Risk Assessment:</u> who is your <u>emergency point of contact</u> on the race day?

Community Involvement



Types of incidents

- Between January 2007 and June 2009, **282 recorded** incidents in the Cam Conservancy Area
- Typical examples:
 - Collisions with moored vessels or riverbank
 - Boat-on-boat collisions (steering error, inappropriate use of speed), sometimes resulting in boat damage, accidental immersion and/or injury
 - Deliberate and/or accidental release of moored vessels
 - Deliberate disruption of races
 - Personal assault, stalking, air rifle fire, stone throwing, dog bite
 - Oil spills
 - Livestock in river (cattle, ponies)
 - Dead or injured wildfowl, conversely aggressive wildfowl ("Mr Asbo")
 - Obstructions in river (trees, large debris, picnic tables)
 - Illegal vehicles using towpath (quad bikes, mini-motos, scooters)
 - Illegal fishing during 'Close Season' (15 Mar to 15 Jun inclusive)

Incident 'hot-spots'

- <u>Boathouses</u> loss of concentration, accidents happen within 10 minutes of 'home', look-out for stationary vessels when setting off, beware edge of hardstanding if water levels are high
- <u>Riverside</u> constrained channel heightens collision risk, oil spills (drain overflow)
- Green Dragon Bridge missiles from above, collision risk on corner
- **Stourbridge Common** vessels adrift, noise complaints
- Long Reach assault, speeding motor vessels
- <u>Ditton Corner</u> morning 'log jam', collisions
- Plough Reach/The Gut collision zone, fallen trees, illegal fishing
- A14 bridge antisocial behaviour, vandalism
- <u>Baits Bite</u> late spinning, vessel collisions, mini-motos and quad bikes on towpath
